What is Probate?

Probate is the term commonly used to describe the process of finalising and distributing a deceased person's estate.

Do I need Grant of Probate?

If the deceased has left a will, a Grant of Probate from the Probate Registry may be required. This is to confirm the named Executors' authority to deal with the deceased person's assets, particularly if there is a property involved.

What if there is no Will?

If the deceased did not make a will, then their next of kin may need to apply to the Probate Registry for a Grant of Letters of Administration to enable them to finalise affairs.
